  2. The Party of the 1<sup>st</sup> part has given permission to the 2<sup>nd</sup> part for taking coaching classes for the students of their school. The party of the 1<sup>st</sup> part has requested the party of the 2<sup>nd</sup> part to take UPSC NDA Mathematics Syllabus which will include topics of Paper-1 Mathematics as given in Syllabus of the examination of Union Public Service Commission National Defence Academy & Naval Academy Examination coaching for the students studying in the school.
  3. The party of the 1<sup>st</sup> part has agreed to pay to the party of the 2<sup>nd</sup> part ₹ \_\_\_\_\_ (Rupees \_\_\_\_\_ only) for students studying in the school.
