2. The Party of the 1st part has given permission to the 2nd part for taking coaching classes for the students of their school. The party of the 1st part has requested the party of the 2nd part to take UPSC NDA topics of Paper-II English, General Science and General Studies Syllabus which will include topics of English, General Science and General Studies as given in syllabus of the examination of Union Public Service Commission National Defence Academy & Naval Academy Examination coaching for the students studying in the school.
3. The party of the 1st part has agreed to pay to the party of the 2nd part ₹ _____ (Rupees _____ only) for students studying in the school.
4. The party of the 2nd part will be giving classroom coaching. In addition to this 12 full length Very Similar Tests (VSTs) will be conducted at regular intervals (not more than 09 days) and the result to be submitted within 03 days of the conduct of the VST.
5. The party of the 1st part will pay 10% of the fees as incentive and will pay the fees in three instalments. The 1st instalment (30% of the fee) will be paid on the 35th day of coaching, the 2nd instalment (30% of the fee) on 70th day of coaching and the last instalment (40% of the fee) within seven working days after the completion of coaching.
